Notice of the meeting

A quorum being present, the President, Dame Julia Higgins, took the chair and welcomed members present to the Annual General Meeting.

Record of previous meeting

The President advised the meeting that the record of the Annual General Meeting held on 13 July 2017 had been approved by Council and posted on the members' section of the Institute's website.

Annual report and accounts for the year ending 31 December 2017

The Honorary Secretary, Brian Fulton, gave a short presentation highlighting some of the Institute's activities in 2017 and proposed the adoption of annual report of Council for the year ending 31 December 2017. This was agreed *nem con*.

The Honorary Treasurer, Julian Jones, gave a short presentation on the Institute's financial position and proposed the adoption of the accounts for the year ended 31 December 2017. This was agreed *nem con*.

Resolution 1 – Membership Subscriptions For 2019

The Vice-President for Membership, Mark Telling proposed that annual membership subscriptions from 1 January 2019 be frozen at 2018 rates and set out as below:

Angela Newing and Deborah Phelps, the appointed scrutineers, confirmed that the proxy votes were correct. The votes cast (including proxy votes) were 1355 in favour and 207 against.

The President declared the motion carried with the necessary simple majority of over 50% of members voting in person or by proxy.

Resolution 2 – Reappointment of Auditors

The Honorary Treasurer, Julian Jones proposed that that Price Waterhouse Coopers (PwC) be reappointed as the auditors of the Institute of Physics to hold office until the conclusion of the AGM in 2019 and that their remuneration be fixed by Council

No comments were received from the floor.

Angela Newing and Deborah Phelps, the appointed scrutineers, confirmed that the proxy votes were correct. The votes cast (including proxy votes) were 1466 in favour and 99 against.

The President declared the motion carried with the necessary simple majority of over 50% of members voting in person or by proxy.
